6 Standing Committee Reports

A Admissions and Standards (A&S)

The meeting minutes of 2023-09-26, 2023-10-10 and the draft meeting minutes of 2023-10-24 were submitted for information and required motions.

Effective start date May 2024.

Discussion:

This is a new program. It is a government initiative. Selkirk College is the first institution to run this type of program. This will be a modular based program, 8 weeks for each module. The program will start in May 2024. The courses for this program will have some changes and will be submitted through the committee process in the new year. If there are enough hours, and if the Future Skill Grant funding gets renewed, this program may qualify for grant funding. Can you ladder into this program? There is a possibly yes. Could it be a micro credential? Possibly. There was a question asked about the statement in the policy stating that not having the means of transportation could mean you don't get a practicum placement. This needs to be here and in most cases is not an issue. The program bends over backwards to ensure that students get practicum placements. Interior Health Authority has already contacted us. It was mentioned to connect with the First Nations Health Authority to discuss this program with their developers.

"Pursuant to the CIA Section 23(1)(b) and the CIA Interpretation Tool for the Board, Education Council and President (March 2016, Updated June 2021), Admissions and Standards recommends that Education Council approve the new graduation requirements for the Associate of Science in Biology appendix found in the UAS Program Policy."

Discussion:

This program had the graduation requirements and the course of studies tables updated. The new wording was not very clear in the graduation requirements. It was confusing as to what the student were required to take. Provincial guidelines, outlining the requirements of an associate degree, were followed. But it was acknowledged that yes, the requirements were confusing. It was also asked if the order of the courses in the tables was the order that the courses must be taken. The answer was no. It was then suggested that the course of studies table indicate



that they were showing a sample of how the courses could be taken. With uncertainty about what is required this change was deferred to a future meeting so that the program could look at the requirements to see if they could make the language clearer.
