DEAR APPLICANT,

Greetings and thank you for your interest in the Rural Pre-Medicine Program.

Canada has a serious shortage of health professionals providing care to rural communities. One strategy to address this situation involves increasing the number of applications to professional health programs from applicants who show a connection to and interest in rural living. With support from the Ministry of Health and the Doctors of BC, Selkirk College is excited to offer a program that is specifically developed to open a door for competitive applications from these sorts of students. Students will be given the opportunity to maximize their academic potential and develop the experiences and training that will prepare them for the unique challenges of being a health professional in a rural setting.

Successful completion of our program means that a student will meet the requirements to apply to the UBC Faculty of Medicine's MD Undergraduate Program and the U of C Doctor of Medicine Program. We cannot guarantee admission (e.g., only 10% of applicants to UBC's MD program are successful in an application cycle), but the program is designed such that student's applications will be competitive. If being a medical doctor isn't your specific goal, our program also fulfills the requirements for entry into many other health-related fields such as veterinary medicine, dentistry, chiropractics, pharmacy, etc.

GENERAL INFORMATION

The recommended application deadline is February 1.

Thank you for your interest in the Rural Pre-Medicine Program. Please complete all of the necessary sections in this package. Admission to the Rural Pre-Medicine Program is a competitive process. Students who have completed their applications and who meet the program pre-requisites will be ranked based on a combination of academic and non-academic qualifications. The top qualified applicants will be offered seats; the remaining qualified applicants will be placed on a ranked waiting list. If you are offered a seat, you will be given a fixed time to accept by providing a seat deposit. The admission process uses a continuous intake model. This means that outstanding applicants will be accepted into the program before the final deadline. Applications not accepted early will be held until the closing date and considered in a final round of selection.

Part of the mandate of the Rural Pre-Medicine Program is to encourage Indigenous applicants. Selkirk College recognizes Status and Non-Status Indians, Treaty, First Nation, Métis and Inuit peoples as Indigenous peoples of Canada. If you wish to be identified as an Indigenous applicant, please contact the program.

Selkirk College also welcomes international applicants to our Rural Pre-Medicine Program. These students should be aware that their citizenship and residency status will have an impact on their eligibility to attend medical schools within Canada and also to be licensed to practice medicine. It is incumbent on all students to determine whether they are eligible to pursue a medical career.
