Overview of program plans for the 21-22 academic year

The college was at 34% in-person delivery in 2020 and now in the 2021 term we are back to the 2019 numbers. Some programs have continued with remote learning to better serve the students. Some programs have adopted a hybrid model of delivery. Academic Upgrading and University of Arts and Sciences programs have more online learning options than some other programs. The plan is to go back to 100% in-person delivery for the Winter 2022 term. But this will depend on each school/program. There was an update that International Students would need to return to in-person classes for the Winter 22 term. But this could change. As updates are made available the Council will be updated.

Policy 8100 updates

There is a new working group that is working on completing the updates to this policy.

Curriculum Strategy (formerly SmartCatalog) update
