Discussion:

There is a big demand for the ECCE program, especially from International Students. There will be some courses taken out of the current program and others will be added. The goal is to make this program more internationally friendly. It was questioned of why we need this new program if a similar program already exists? Data shows that international students are not very successful in the current ECCE program. This program will have courses that will better support them.

The goal is to integrate, deliberate, and work together – both domestic and international students.

The current ECCE program will be going through a Level 3 program review in the 23-24 term. More recommendations may come from this review.
